

ORDER

In exercise of the powers conferred under Rule 8 of the Central Civil Accounts Service (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2016, the Central Government hereby relaxes the condition of "on request by officer" in the Rule 6(2) of the ibid rules.

2. The Controller General of Accounts may, if he is satisfied that it is necessary or expedient in public interest so to do, by order, and for reasons to be recorded in writing, transfer an Accountant or Senior Accountant in the accounts organizations under O/o CGA from one Ministry to the other in the same grade.

3. This relaxation shall be allowed till the finalization of new Recruitment Rules for the above said posts or further orders in this regard, whichever event occurs earlier.
