**Minutes of the review meeting** held on 07.06.2016 in SWASTI, Office of Controller General of Accounts.

Annual Accounts for the financial year 2015-16 is to be finalized by 30<sup>th</sup> September 2016, for which intermediate timelines for submission of Stage-II of Head wise Appropriation Accounts, SCTs and Non- Accounting Statements of Finance Accounts were up to 30<sup>th</sup> May 2016. To review the progress of preparation of accounts, a meeting under the chairmanship of Additional Controller General of Accounts held on 07.06.2016 in Swasti, Lok Nayak Bhawan, New Delhi with some Grant Controllers.

Addl. CGA addressed the meeting and conveyed that this office would like to facilitate the Ministries/ Departments having difficulties in submission of Accounts and gave a brief background on the timelines for finalization of the Annual accounts. He said that the decision to prepare the Union Annual Accounts 2015-16 within six months of closing of the financial year, similar to international best practice and practice followed in the corporate sector in pursuance to the Companies Act 2013, is internal not imposed by any Statute or Rules. He requested those present to confirm that Stage-II Appropriation Accounts would be submitted by 10<sup>th</sup> June 2016 (Friday). CCA (MOF) suggested that the composite approval of Interest Payments involved multiple Civil Ministries/ Departments and Railways and could be held up. He was requested to use the SCT of Railways already submitted.

After detailed discussion on the issue, the Addl. CGA proposed that remaining Ministries/ Departments should submit the Stage-II of Head wise Appropriation Accounts latest by 10-06-2016 with simultaneous submission of required copy/documents to Director General of Central Expenditure (DGCAE).

Additional CGA appreciated the collaborative efforts and focus of office of CGA and field formations on due diligence and quality of the accounts which reflected in substantial reduction in the number of Journal Entries (JEs); dropped from 243 JEs prepared in 2011-12 to only 60 JEs for 2014-15. As observations on SCT review have been shared with Grant Controllers and due date for submission of JEs is 22-06-2016, the CCAs/CAs were requested to apprise him, through a DO letter, by 15-6-2016 about problems, if any, in submitting the JEs, if any, within due date.

In view of delay in Audit of SCT, as intimated by the DGCAE, Addl. CGA stressed that efforts are needed for finalization of residual Statements on time. He added that any communication on Annual Accounts to O/o C&AG or DGCAE, invariably should be sent with prior-approval of concerned CCAs / CAs.

The meeting ended with a note of thanks.
