The undersigned is directed to append below the Agenda Points for CGA's Meeting with Pr CCAs/CCA/CA (Independent Charge) on 27th June 2016.

A. Induction Training for Accountants

We have vide OM dated 3rd May 2015 circulated a policy regarding training of Group B and C officials. Accordingly, 1st Batch of 80 Accountants was nominated for training.

- i. **Non-reporting of selected Candidates:** 5 candidates have not reported till 20th June 2016 (List enclosed "A")
- ii. **Late Arrival:** It is appraised by INGAF that nominated candidates are not adhering to the time, and are reaching late for the sessions. This result in disturbing the training schedule. (List of late comers attached "B").
- iii. **Replacement of nominated candidates:** Some of the Ministries/Deptt have suo-motto changed the name of participants without prior notice/approval of this office.
- iv. **Non furnishing nomination for next batches:** Ministries/Deptt have not responded by nominating candidates for next batches.

B. Review under Rule FR 56(J)

This office has issued OM dated 30th May 2016 regarding strengthening of administration.

- i. **Periodical Reviews under FR 56 (J) and Rule 48 of CCS(Pension) Rules 1972.** Except for Ministry of Power none of the Ministry/Deptt has responded so far. Only some of the Ministries/Deptt have collected the APAR (List attached "C")

C. Wanting Vigilance Clearance and APAR




