Promotion of Lower Division Clerks (LDCs) as Accountant on the basis of seniority in terms of Provisions contained under Rule 5 (2) (C) of Central Civil Accounts Service (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010.

The undersigned is directed to state that in terms of the provisions contained under Rule 5 (2) (C) of Central Civil Accounts Service (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010 and on the basis of select list of eligible LDCs for the vacancy year 2013-14 furnished by Pr. CCAs / CCAs / CAs / Dy. CAs, the LDCs as per details given in the Annexure have been approved for promotion as Accountant and allocated to Ministry / Department indicated against each.

- 2. These LDCs have already been found fit by the respective DPCs where they are currently employed. Therefore, the Competent Authority of the Ministry / Department to whom these LDCs are allocated is to issue their appointment orders. However, before doing so it may be ensured:
- (i) That none of the circumstances laid down in DP & T OM dated 14.09.1992 regarding adoption of seal cover procedure or subsequent instructions of the Government of India exists.
- (ii) That none of them are undergoing any penalty under CCS (CCA) Rule, 1965.
- (iii) Their date of appointment as LDC in CCAS only is taken into account for the purpose of seniority.
- (iv) Those who are promoted are to categorically state as to whether they accept the offer of promotion or not, within a period of 60 days from the issue of this OM. Those who fail to state their acceptance within the stipulated time shall be deemed to have refused promotion and will be debarred for promotion for a period of one year from the date of refusal or till a vacancy arises, whichever is later as per existing guidelines of DOP & T in this regard.
- (v) The appointment / promotion order may be issued latest by 15.06.2013.
