## Sub: Implementation of Government's decision on the recommendation of the Sixth Central Pay Commission - Revision of pension/family pension -reg

Ministry of Personnel, Public Grievances & Pensions, (Dept. of Pensions & Pensioners' Welfare) have issued the under mentioned office memoranda regarding revision of pension/family pension etc. in respect of retired Government employees:

- (1) No.38/37/08-P&PW(A) dated 1-9-2008-applicable to those pensioners/ family pensioners who were drawing / entitled to pension/ family pension on 31-12-2005
- (2) No.38/37/08-P&PW(A) dated 2-9-2008 -applicable to government servants who retire / die in harness on or after 1-1-2006.

2. Chief Controllers of Accounts/Controller of Accounts are requested to bring the contents of the above mentioned Office Memoranda to the notice of the Pay & Accounts Offices under their control and issue suitable instructions to them to take necessary action in accordance therewith and to ensure the expeditious disposal of pension cases with the least inconvenience to pensioners.

3. Since delay in settlement of revision cases may result in hardship to the pensioners, it is requested that the CCAs/CAs may watch the progress of family pension/pension revision cases by introducing an appropriate monitoring mechanism such as weekly/fortnightly report from the Pay & Accounts Offices. They may also forward a monthly report on the receipt and settlement of revision of pension/family pension cases to this office in the enclosed proforma along with the monthly D.O. to CGA. The first report on the subject may be sent with the Pr. CCA/CCA/ CA's monthly D.O. to be sent to Controller General of Accounts in the first week of October, 2008.
