Sub:- Central Administrative Tribunal, Chennai Bench Order dated 29.12.2010 passed in OA No. 966 and 967 of 2009 - Extending the benefit of the MACP Scheme in favour of the AAOs of CCAS by fixing their grade pay of Rs. 5400/- w.e.f. the date on which the said benefits was extended to the Sr. Accountants of CCAS.

A large number of representations have been received in this office from the AAOs of CCAS working in Departmentalized Accounting Organization in Ministries/Departments for grant of Grade Pay of Rs. 5400/- to AAOs by extending the benefit of Hon'ble CAT judgment passed in O.A. No.966 No. 967 of 2009 dated 29.12.2010.

- The matter was referred to Ministry of Finance, Department of Expenditure. Ministry of Finance, Department of Expenditure in consultation with DoP&T has clarified vide LD. No. A-12034/15/2015-Ad.I dated 15.10.2015 (copy enclosed) that in view of Para 10 of DoP&T's O.M. dated 19.05.2009, AAOs in CCAS are not eligible for grant of higher grade pay with regard to junior who are getting more pay than the seniors on account of pay fixation under MACP Scheme. DoP&T has advised that the rule position as above may be followed.
- 3. In view of above clarification, all representations received from AAOs of CCAS working in Departmentalized Accounting Organization in various Ministries/Departments may be treated as disposed off.
